The aim of the Archdiocesan Allocation Committee is to assist with funding Catholic and community organisations. The priority is to fund organisations who are working in areas identified as priorities by The Tindall Foundation and aligned with the Archdiocesan goals.

We are charged, by the Archbishop, with the funding support of groups committed to social, pastoral, charitable and educational needs in our region. Applications are judged on the basis of need, resource availability and the fulfillment of set criteria.

PROFILE

The Tindall Foundation (TTF)

TTF makes an annual grant to the New Zealand Catholic Bishops Conference (NZCBC). The NZCBC is a 'Faith-based' funding manager for TTF. The Tindall Allocation Committee acts as the NZCBC agent in the Archdiocese. TTF's vision is that it should play a supportive role in the philanthropic sector in New Zealand and that it should contribute to healing problems rather than managing them. The Archdiocese of Wellington (Archdiocese)

The Archdiocesan region spans the central New Zealand area from a line between Levin and Masterton in the north to the southern boundary from Kaikoura to Westport. There are 22 Parishes and a number of schools, both primary and secondary. There are also central pastoral agencies coordinating services as diverse as Catholic education, youth and young adult ministry, ministry with Pacific peoples, family life, Catholic Māori, management of funds and social services. Other centralised support services cover such activities as employment, legal, property, archives and library. There are a number of groups in the Archdiocese, both Catholic and community based, who share common goals in social service, education and charity.

All organisations who share common goals are invited to apply for funding.

PROCESS

Drawing from the funding base, the Archdiocesan Allocation Committee allocates resources based on criteria as outlined on the Goals and Priorities information page. Allocations are made annually and applications close:
